An exciting new project between clothing industry partners to cut carbon, water and waste, bringing environmental and economic benefit to the sector and supporting a circular economy.

ECAP reducing clothing waste across Europe

ECAP addresses the environmental challenges at every stage of the European clothing industry's life cycle. Delivered by a unique consortium of specialist organisations, supported by EU LIFE funding, this €3.6m project will run until March 2019.

Targets (2015 baseline)

- Divert 90,000 tonnes of clothing waste from landfill and incineration
- Save 1.6 million tonnes of CO_{2e}
- Make 588 million m³ of water savings

Creating a circular approach to fashion across Europe

ECAP is happening now

This new initiative, started in September 2015, is the only EU LIFE-funded project to address clothing sustainability.

Following the success of the Sustainable Clothing Action Plan in the UK, ECAP is developing a pan-European framework centred on a set of target-based actions that will:

- Reduce the carbon, water and waste footprints of clothing in Europe
- Ensure that fewer low grade textiles go to incineration and landfill
- Prevent waste in the clothing supply chain
- Encourage sector innovation and growth in resource-efficient design, recycling of textile fibres and service models
- Influence consumers to buy smarter and use clothing for longer
